## AUTHORIZING CONTRACTS WITH CERTAIN APPROVED STATE CONTRACT VENDORS FOR CONTRACTING UNITS PURSUANT TO N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-77.15

WHEREAS, N.J.S.A. 40A:11-12 provides that a contracting unit may, without advertising for bids, purchase any materials, supplies or equipment under any contract entered into on behalf of the State by the Division of Purchase and Property in the Department of Treasury and local Cooperative Contract Purchasing Systems; and,

WHEREAS, has authorized purchases under the appropriate State Contract and Cooperative Contract Purchasing Systems, and utilized the bidding advantage done by the State and Cooperatives; and,

WHEREAS, it is desirable from time-to-time to obtain materials, supplies and equipment under contracts for such materials, supplies and equipment entered into on behalf of the State by the said Division and local Cooperative Contract Purchasing Systems without the necessity of advertising for bids, or in the cases where no bids have been received; and,

WHEREAS, it is contemplated that it will be necessary or desirable to obtain materials, supplies and equipment under such contract or contracts entered into on behalf of the State of New Jersey by said Division and Local Cooperative Contract Purchasing Systems during the year 2024;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Fire Commissioners of the Evesham Township Fire District Number 1 as follows:

1. That the purchases by the Evesham Township Fire District No. 1, shall be purchased under a contract or contracts for such materials, supplies and equipment entered into on behalf of the State of New Jersey by the Division of Purchase and Property in the Department of the Treasury and Local Cooperative Contract Purchasing Systems as documented in attachment A, in those cases where it is desirable and in the best interest of the Evesham Township Fire District No. 1, and in the case where bids have been sought by advertisement therefore and no bids are received.

This resolution shall become effective immediately upon final adoption.
