**A RESOLUTION AUTHORIZING APPLICATION TO DCA FOR  
FIRE GRANT**

**WHEREAS**, Evesham Township Fire District No.1 (hereinafter EFD) is tasked with the responsibility of providing fire suppression, emergency medical, code enforcement, and rescue services within the Township of Evesham; and

**WHEREAS**, EFD utilizes personal protective equipment (hereinafter PPE) during the provision of these services in order to protect its responders from the hazards associated with emergency response; and

**WHEREAS**, the COVID-19 global pandemic along with recent surges in COVID-19 variants continue to present a threat to the health, safety, and well-being of EFD's emergency response personnel during their response to emergencies; and

**WHEREAS**, EFD desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately Seventy-Five Thousand Dollars (\$75,000.00) to outfit its cadre of firefighter/EMTs and emergency medical technicians with the personal protective equipment necessary to perform the daily duties of their respective job functions, and


**WHEREAS**, included in this project is the replacement of frontline PPE, to include that which has been utilized during the COVID-19 global pandemic, that which has exceeded its serviceable life, and that which is no longer serviceable.


**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of the Evesham Township Fire District Number 1 as follows:

- 1) that the Evesham Township Fire District No.1 does hereby authorize the application for such a grant; and,
- 2) recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between Evesham


Township Fire District No.1 and the New Jersey Department of Community Affairs.


