RESOLUTION No. 2024 - 40

A RESOLUTION AUTHORIZING CAPITAL PROJECTS PURSUANT TO N.J.S.A. 40A:14-84

WHEREAS, the Board of Fire Commissioners of Evesham Township Fire District No. 1, County of Burlington, State of New Jersey (hereinafter referred to as the "Board"), finds it necessary, in order to fulfill its mandated charge of fire prevention and fire protection within the District, to undertake certain Capital projects, namely, the acquisition of Fire Apparatus consisting of an fire engine truck with related equipment, acquisition of Fire/EMS equipment including personal protective equipment, AED's, gas detectors, suction machines, hose, and various building improvements including station equipment; and

WHEREAS, prior to inclusion of any Capital project in the Board's annual budget, N.J.S.A. 40A:14-84 and the Department of Community Affairs, Division of Local Government Services mandates that such project(s) must be approved by the Board of Fire Commissioners of the District, and

WHEREAS, N.J.S.A. 40A:14-84 requires the Board to hold a public meeting to discuss said Capital projects and the amount of money to be raised for same by posting and publishing notice of the meeting called for the purpose thereof; and

WHEREAS, pursuant to said statute, the date, time, place and object of the special meeting was posted at five (5) public places on August 29, 2024, at least ten (10) days prior to said meeting; and

WHEREAS, a special meeting was held at the regular meeting on September 10, 2024 at 7:00 p.m. wherein the above set forth Capital project(s) and funding for same were discussed; and

WHEREAS, after discussion by the Board, the meeting was open to public for comment; and

NOW, THEREFORE BE IT RESOLVED by the Board of Fire Commissioners of the Evesham Township Fire District No. 1 in the Township of Evesham, County of Burlington that it shall include in its 2025 Annual Budget for approval and adoption by the Department of Community Affairs, Division of Local Government Services, the following Capital project(s) in an amount not to exceed that which is set forth:

- (a) undertake a capital improvement program consisting of:
 - (i) the acquisition of fire engine truck all with related equipment in an amount not to exceed \$1,300,000; and

- (ii) acquisition of Fire/EMS equipment including AEDs, gas detectors, suction machines, firefighter personal protective equipment and hose in an amount not to exceed \$175,000,
- (iii) Building improvements to include doors, parking improvements, building renovations, storage building, drainage, concrete, carpet, audio visual equipment, and safety enhancements, including related station equipment in an amount not to exceed \$405,000;
- (b) expend for all the foregoing an amount not to exceed \$1,880,000.00.

BE IT FURTHER	RESOLVED,	that	the	within	Resolution	shall	be	effective
BE IT FURTHER immediately upon passage.
