## A RESOLUTION AUTHORIZING A CONTRACT FOR PROFESSIONAL MEDICAL DIRECTION SERVICES

WHEREAS, there exists in Evesham Township Fire District No. 1 a need for a Medical Director to perform Medical oversight for the Fire District; and

**WHEREAS**, pursuant to the provisions of N.J.S.A. 19:44A-20.4, et seq., the Board of Fire Commissioners has determined to award said contract as a fair and open contract; and

**WHEREAS**, funds are available for these purposes in an amount not to exceed \$9,500; and

WHEREAS, the Local Public Contracts Law (NJSA 40A:11-1, et. seq.) requires governing body of a contracting unit to publish a notice in a newspaper authorized by law to publish its legal advertisements, setting forth the nature, duration, service and amount of the contract where such contract is awarded for "professional services".

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Fire Commissioners of Evesham Township Fire District No. 1 as follows:

- 1. That a contract by and between the Evesham Township Fire District No. 1 and Dr. Kenneth G. Lavelle, doing business as East Coast Medical Consultants, 3121-D Fire Road, PMB 104, Egg Harbor Township, NJ 08234, for the provision of Medical Direction is hereby approved and authorized for the fiscal year 2025 and until the next reorganization meeting of the Board;
- 2. The appropriate officers of the Evesham Township Fire District No. 1 are hereby authorized to enter into the contract with the firm for the Medical Direction services above specified.
- 3. The contract is awarded as a "professional service" under the provision of the Local Public Contracts Law because the specialized training, education, experience and specialized knowledge needed for this position and pursuant to a "fair and open" process as provided in N.J.S.A. 19:44A-20.4 et seq.
- 4. A notice of the award of this contract shall forthwith be printed once in the Burlington County Times, an official newspaper of the Evesham Township Fire District No. 1. authorized by law to publish the legal advertisements of the Evesham Township Fire District No. 1, setting forth the nature, duration, service and amount of the contract, and further stating that this resolution and the annexed contract are on file and available for public inspection in the Office of

the Business Administrator as required by law within ten (10) days of its passage.

This resolution shall take effect immediately.
