AWARDING A CONTRACT FOR ONE (1) PIERCE ENFORCER PUMPER, 4-DOOR FULL TILT ALUMINUM CAB, FORMED ALUMINUM BODY, SINGLE AXLE

- WHEREAS, P.L. 2011, c.139 allows local contracting units to utilize national cooperative contracts as a method of procurement of goods and services; and,
- **WHEREAS**, Houston-Galveston Area Council (H-GAC) is a regional planning commission and political subdivision of the State of Texas operating under Chapter 391, Texas Local Government Code; and,
- WHEREAS, pursuant to the Act, H-GAC is authorized to contract with eligible entities to perform governmental functions and services, including purchase of goods and services; and,
- WHEREAS, in reliance on such authority, H-GAC has instituted a cooperative purchasing program under which it contracts with eligible entities under the Act; and,
- WHEREAS, Evesham Township Fire District No. 1 has joined and is a member of the H-GAC cooperative purchasing program and is eligible to purchase goods and services available under contracts that have been duly awarded by the H-GAC; and,
- WHEREAS, H-GAC has awarded a contract that was publicly advertised and bid to Fire & Safety Services LTD under contract number #FS12-23 for one (1) Pierce Enforcer Pumper, 4-Door Full Tilt Aluminum Cab, Formed Aluminum Body, Single Axle; and,
- **WHEREAS**, the Business Administrator, in accordance with the requirements of P.L. 2011, c. 139 has recommended to the Board of Fire Commissioners the use of the contract awarded by H-GAC to purchase a ladder truck for the reasons of efficiency and economy; and,
- WHEREAS, The New Jersey Department of Community Affairs in LFN 2012-10, sets forth that a government authority must engage in a procedure that assert that cost savings benefits will be achieved, and further that the national contract entity has demonstrated that it has met appropriate New Jersey requirements; and,
- WHEREAS, the District has engaged in a process wherein such requirements have been satisfied, and further has approved of the process as previously demonstrated by the passage of Resolution 2013 29 on May 13, 2013; and,
- **WHEREAS**, funds have been authorized and are now available for this purchase under the 2025 Capital Budget;
- **NOW, THEREFORE, BE IT RESOLVED,** by the Board of Fire Commissioners of the Evesham Township Fire District No. 1 as follows:

- 1. That a purchase contract for one (1) Pierce Enforcer Pumper, 4-Door Full Tilt Aluminum Cab, Formed Aluminum Body, Single Axle, in an amount not to exceed \$1,207,893.00, pursuant to the terms and conditions of the H-GAC contract number #FS12-23, be and is hereby approved and authorized.
- 2. The total amount authorized for this purchase shall not exceed \$1,207,893.00.
- 3. Funds for this purchase are available for and are being certified against the 2025 Capital Budget.
