A RESOLUTION AUTHORIZING A SHARED PERSONAL PROTECTIVE EQUIPMENT (PPE) AGREEMENT

WHEREAS, Evesham Township Fire District No. 1 ("EFR") and Mount Laurel Fire District #1 ("MLFD") are public entities engaged in providing emergency services; and

WHEREAS, the entities have agreed that it would be beneficial to lend/lease personal protective equipment ("PPE") from the Mount Laurel Fire Department to Evesham Township Fire District No.1 under the conditions hereinafter set forth.

NOW, THEREFORE, in consideration of the foregoing premises and mutual covenants and promises contained, the parties agree as follows:

- (1) The entities agree to the lending of PPE from the Mount Laurel Fire Department to Evesham Township Fire District No. 1 to be used solely by the former volunteers from the Mount Laurel Fire Department in their new membership at Evesham Township Fire District No. 1.
- (2) Evesham Township Fire District No. 1 shall remove 'Mount Laurel' from the turnout coat and may relabel the coat to the Evesham Township Fire District No. 1 standard. All costs associated with the removal of and relabeling shall be the responsibility of Evesham Township Fire District No. 1.
- (3) If any claim results related to the use of the PPE, Evesham Township Fire District No. 1 shall hold harmless and indemnify MLFD, its officers, commissioners, agents, or employees from any damage and injury arising from the use of the PPE. It will be Evesham Township Fire District No. 1's responsibility to determine the viability and service quality of the PPE.
- (4) Evesham Township Fire District No. 1 shall bear the responsibility and cost related to the use and/or damage of the PPE. Regular inspection and maintenance of the PPE will be the responsibility of EFR.

- (5) MLFD shall inspect all PPE before lending to EFR. MLFD will also provide EFR with a written list/spreadsheet of equipment to be loaned.
- (6) Either party may terminate this agreement with 30 days' written notice to the other party.
- (7) This agreement shall be terminated no later than one year from when the agreement was made, unless both entities agree in writing to the extension of this agreement.
- (8) At the conclusion of this agreement, EFR will remove all Evesham Township Fire District No. 1 identification from turnout coats before returning equipment to MLFD.
